#### **Exhibition Guidelines:**

- Each artist may submit a total of 2 artworks in either 2D and/or 3D, in any medium. <u>Your name, the artwork title and the price</u> must be attached on the bottom or the back of each artwork.
- **All work must be original.** 2D work must not be larger than 9 sq. ft. No political or inappropriate subject matter. The AFAF Board reserves the right to refuse art that does not meet gallery guidelines.
- All 2D work must be wired for hanging (no saw-toothed hangers), matted and framed to present professionally. Half sheet size or smaller is preferred. Plexiglass is recommended on larger works, but is not mandatory. We will not hang unframed canvasses unless they are at least 1.5 inch deep (museum depth) with finished edges. Unacceptable works must be picked up by the artist ASAP as there is no storage space at the gallery.
- AFAF will do advertisement consisting of newsletter to our mailing list and postings on the AFAF website, Facebook and Instagram feeds.
- You must sign a waiver of liability for work being displayed in the gallery. We will not be responsible for damage to artwork. We take all reasonable care of your work. You must have your own insurance.
- The gallery charges a 30% Commission on works sold that are over \$100 and 20% on all works that are \$100 or less.
